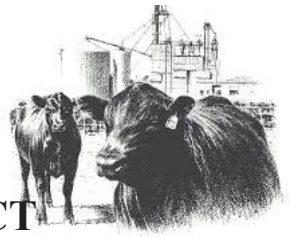

within the meaning of the Federal Food, Drug and Cosmetic Act (ie., non of the cattle or other ruminants will have been fed any feed containing protein derived from
