If Seller defaults, Seller and agent shall be liable to buyer for return of the \$100.00 per head down payment. In case of default, the defaulting party shall be liable for actual & incidental damages plus court costs & reasonable attorney's fees. Seller shall handle livestock in their normal and usual manner until delivery, unless otherwise expressly agreed in writing. Payment will not be made until all affidavits are in place. Seller shall furnish to Buyer any Brand and Health Certificates required by Federal & State Law. The undersigned certifies that, to the best of his/her knowledge, as of the date of shipment or delivery, to Cattle Country Video will be, on such date, unadulterated within the meaning of the Federal Food, Drug and Cosmetic Act (ie., none of the cattle or other ruminants will have been fed any feed containing protein derived from mammalian tissues, e.g. meat & bone meal, as that term is derived from 21CFR 589.2000 and non of the livestock will have an illegal level of drug residues). This certificate shall remain in full force & effect until revoked in writing by the undersigned seller and such revocation is delivered to market.
